AN ORDINANCE VACATING RIGHTS-OF-WAY IN THE CITY OF AUBURN, INDIANA

In accordance with the provisions set forth in Indiana Code §36-7-3-12, this ordinance shall vacate a portion of the platted McNair Lane Right-of-Way.

The right-of-way proposed to be vacated includes the portion of McNair Lane right-of-way which abuts Lots 105 and 106 in Pheasant Run I Section V; Virginia Lane right-of-way; and the easterly line of Pheasant Run I Section V Secondary Plat.

The City of Auburn shall retain a public utility easement over said real estate to maintain existing utility infrastructure in accordance with Indiana Code §36-7-3-16. ORDINANCE NO. 2020-03

AN ORDINANCE VACATING RIGHTS-OF-WAY IN THE CITY OF AUBURN, INDIANA

WHEREAS, a petition to vacate certain public rights-of-way has been submitted to the City of Auburn, Indiana by Larry and Elaine Warstler owners of Lot 105 in Pheasant Run I Section V and Christopher and Deborah Mays owners of Lot 106 in Pheasant Run I Section V; and

WHEREAS, the City of Auburn desires to vacate certain right-of-way more particularly described as follows:

All of the right-of-way of McNair Lane contained within the Secondary Plat of Pheasant Run I Section V, an addition to the City of Auburn, DeKalb County, Indiana, according to the plat thereof recorded in Plat Book 8 at page 110 in the Office of the Recorder of DeKalb County, Indiana. Said portion of right-of-way being bounded on the west along the easterly right-of-way line of Virginia Lane, bounded on the south along the northerly line of Lot 105 in said Secondary Plat of Pheasant Run I Section V, bounded on the north along the southerly line of Lot 106 in said Secondary Plat of Pheasant Run I Section V, and bounded on the east along the easterly line of said Secondary Plat of Pheasant Run I Section V.

WHEREAS, said right-of-way is unimproved with regard to pavement and driving surface, is already maintained by adjacent property owners, and serves no connection to the east; and

WHEREAS, a Public Hearing was held on March 3, 2020 at 6:00 PM by the City of Auburn Common Council in the Norman E. Yoder Council Chambers regarding the petition for vacation; and

WHEREAS, a Public Hearing was held on March 3, 2020 at 6:00 PM by the City of Auburn Common Council in the Norman E. Yoder Council Chambers regarding the petition for vacation; and

WHEREAS, the City of Auburn has provided notice, pursuant to Indiana Code §36-7-3-12(c) and 5-3-1 et. seq. that it desires to vacate certain public right-of-way; and

WHEREAS, a second reading of the Ordinance was held on March 17, 2020, and

WHEREAS, due consideration and opportunity has been given for public notice and comment.

IT IS NOW THEREFORE ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA THAT:

Section 1.

The rights-of-way to be vacated are illustrated in Exhibit A, consisting of two (2) pages, which is attached hereto and made a part hereof further setting forth the area being vacated.

Section 2.

The Municipal City of Auburn shall retain a permanent utility, drainage, and access easement over the entire vacated right-of-way for the purpose of utility use, installation, repair, and/or maintenance; for the purpose of surface drainage; and for the purpose of access to and over the vacated area.

Section 3.


Once this document is executed and recorded, the north half of the vacated right-of-way shall be conveyed to the owner of Lot 106 in Pheasant Run I Section V and the south half of the vacated right-of-way shall be conveyed to the owner of Lot 105 in Pheasant Run I Section V.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after publication of the summary of this Ordinance in a newspaper of general circulation in DeKalb County,
