**AN ORDINANCE AMENDING A PORTION OF THE AUBURN CITY TRAFFIC CODE
RELATED TO TRAFFIC-CONTROL SIGNALS**

SUMMARY:

This Ordinance amends and adds provisions to portions of the Auburn City Traffic Code set forth as follows:

At the intersection of the YMCA Cross Walk and North Street. (Activated Red Light Cross Signal).

Upon passage, the summary of this Ordinance shall be published in a newspaper of daily circulation. The original Ordinance shall be made available to the public in booklet form. The Ordinance shall be codified in Chapter 75 Schedule IV TRAFFIC-CONTROL SIGNALS. ORDINANCE 2021-01

**AN ORDINANCE AMENDING A PORTION OF THE AUBURN CITY TRAFFIC CODE
RELATED TO TRAFFIC-CONTROL SIGNALS**

WHEREAS, this ordinance amends a portion of the Traffic Code of the City of Auburn, Indiana, which is located at Chapter 75 Schedule IV. Said amendment is related to the Traffic-Control Signals; and

WHEREAS, the evidence and findings related to this amendment are justified under state and local law as set forth herein; and

**NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF AUBURN, INDIANA AS FOLLOWS:**

Section 1.

Chapter 75 Schedule IV shall be

Traffic-control signals are installed at the following locations.

Intersection

- Auburn Dr. and Wayne St.
- Grandstaff Dr. and 15th St.
- 7th St. and Cedar St.
- 7th St. and Grandstaff Dr.
- 7th St. and Indiana Ave.
- 7th St. and Jackson St.
- 7th St. and Main St.
- 7th St. and Touring Dr.
- 7th St. and Van Buren St.
- 7th St. and Duesenberg Dr.
- 7th St. and C.R. 35 Flashing signal
- 9th St. and Main St. Flashing signal
- North Street and Indiana Ave. Flashing signal
- I-69 and St. Rd. 8 (W 7th St.) west and east sides
- **At the intersection of the YMCA Cross Walk and North Street. (Activated Red Light Cross Signal).**

All additional traffic control signals installed and not listed herein shall be incorporated by reference and shall be considered valid traffic control signals as long as the signal is installed by a government entity.

Section 2.

This Ordinance shall be in full force and effect after passage by the Auburn City Council, notice of this amendment by publication of the summary of this Ordinance in an appropriate newspaper in accordance with Indiana Code, and by keeping a paper pamphlet/booklet version of this Ordinance and Auburn City Traffic-Code for availability to the public located at City Hall, 210 E. 9th St., Auburn, Indiana in accordance with Indiana Code during regularly posted business hours. Further the provisions set forth herein shall be incorporated into Chapter 75 as set forth in Section 1 of the Auburn City Code which is maintained at the City of Auburn website located at www.ci.auburn.in.us and available for public inspection and review.
