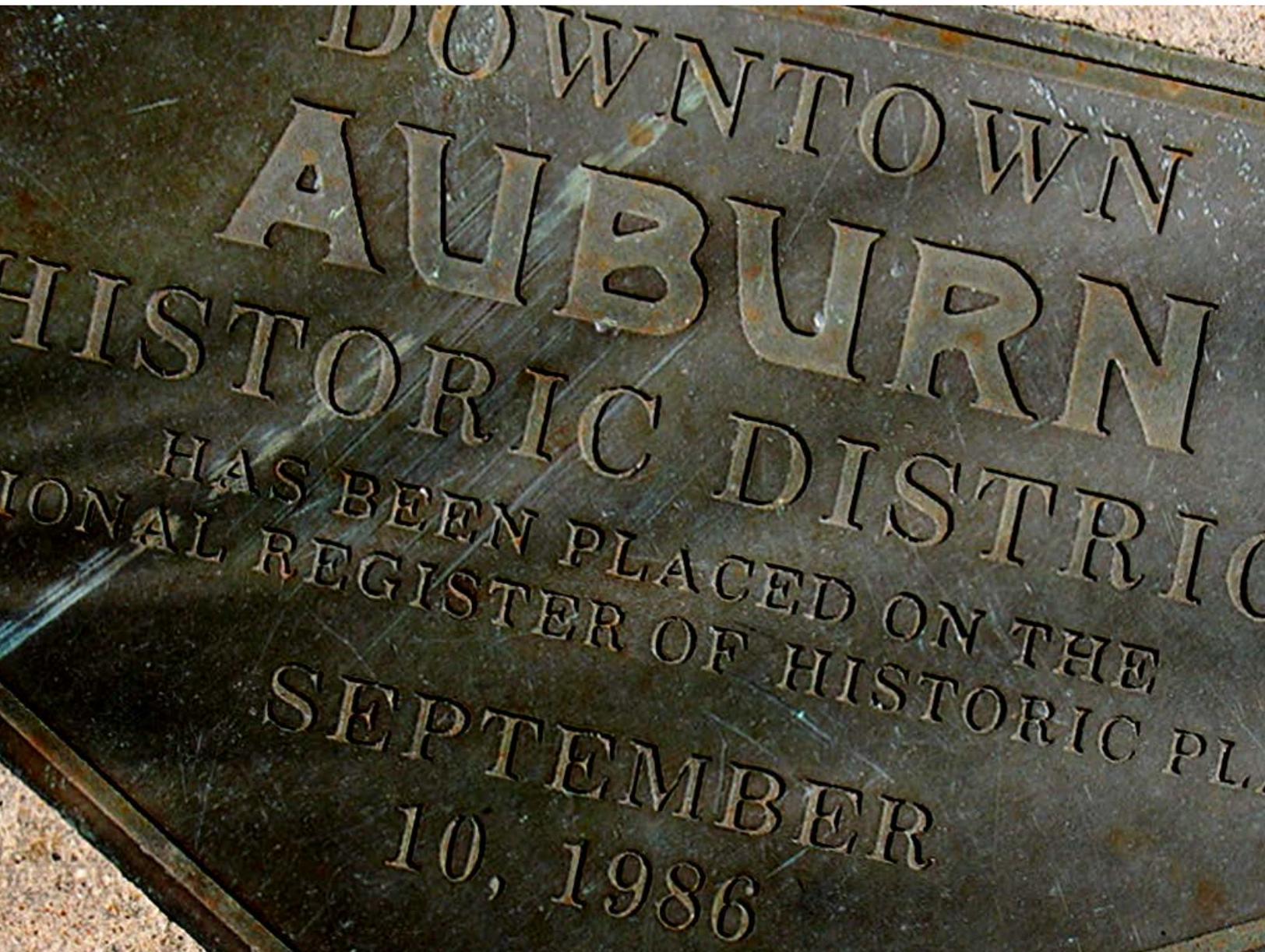

**36.01 ESTABLISHMENT**

There shall be created an Ordinance Violations Bureau for the city.

**36.02 VIOLATIONS CLERK**

The Clerk-Treasurer, or his/her appointee, shall serve as the Violations Clerk of the Ordinance Violations Bureau.

**36.03 PENALTY PAYMENTS**

The Violations Clerk shall accept written appearances, waivers of trial, admissions of violations, and payment of penalties of not more than \$100 for ordinance violations and up to a total of \$2,500.00 maximum per occurrence for violations of Section 130.011 (REPEALED).

**36.04 SCHEDULE OF CITY ORDINANCES**
