WHEREAS, Ordinance No. 2018-24, as amended, adopted an Official Zoning Map for the City of Auburn, Indiana; and

WHEREAS, Indiana Code section §36-7-4-600 et. seq provides for amendments to the zoning map of a municipality by ordinance of the municipality; and

WHEREAS, the City of Auburn Plan Commission, on October 11, 2022, heard input from the public and ultimately forwarded a *favorable recommendation* to the Auburn Common Council, subject to the condition a commitment of use agreement to retain the residential style of the property is recorded, with ten votes in favor of the favorable recommendation and no votes against the favorable recommendation concerning the rezoning of said real estate.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA, THAT:

The Zoning Map of the City of Auburn shall be amended in the following manner: That Lots Numbered Eighty-Nine (89) and Ninety (90) in Highland Addition be rezoned to C1 (Neighborhood Commercial District). The lots are illustrated in Exhibit A, also attached hereto.

BE IT FURTHER ORDAINED that this Ordinance be in full force and effect after its passage by the Common Council and after the occurrence of all other actions required by law.
