**AN ORDINANCE ESTABLISHING A FUND FOR MAINTENANCE OF THE
VETERAN'S MEMORIAL**

SECTION 1. That the Common Council of the City of Auburn, Indiana ("City") desires to establish a fund for the maintenance of the Veteran's Memorial.

WHEREAS, The Common Council of the City has been made aware that the Veteran's Memorial will be dedicated to the City and all maintenance and care will become the responsibility of the City; and

WHEREAS, a separate fund is necessary to properly account for the receipts and disbursements of monies received from any source.

NOW, THEREFORE, BE IT ORDAINED, by the Common Council of the City of Auburn, Indiana, as follows:

1. CREATION OF FUND. The City hereby creates and establishes a special fund known as the Veteran's Memorial Maintenance Fund" to receive and disburse donations received.
2. PURPOSE OF FUND. The primary purpose of the fund is to accurately track the receipts and disbursements of donations made toward the maintenance of the Veteran's Memorial.
3. RESPONSIBILITY OF FUND. The Clerk-Treasurer of the City shall be responsible for the deposits and disbursements of the fund and shall keep records as to the disbursements, receipts, and current balance in such fund at all times.
4. DEPOSIT OF FUNDS. Upon the receipt of donations directed to the Veteran's Memorial Maintenance Fund, the Clerk-Treasurer shall immediately deposit all receipts into the Veteran's Memorial Maintenance Fund.
5. APPROPRIATION AND NON-REVERTING. The Veteran's Memorial Maintenance Fund shall be a non-appropriated and non-reverting fund.
6. DISSOLUTION OF FUND. The fund shall be perpetual unless or until terminated or amended by the Common Council of the City. Upon termination of the fund, the balance thereof shall revert to the General Fund.


