A RESOLUTION AUTHORIZING THE USE OF OPIOID SETTLEMENT FUNDS FOR APPROVED OPIOID REMEDIATION PURPOSES

WHEREAS, the City of Auburn has received funds as part of the Indiana Opioid Settlement, which must be used for opioid remediation purposes; and

WHEREAS, Indiana Code 4-6-15 requires all expenditures of opioid settlement funds to support opioid prevention, treatment, recovery, harm reduction, and other approved abatement strategies; and

WHEREAS, the Common Council finds it in the best interest of the City to allocate a portion of these funds for an approved project addressing the local impacts of the opioid epidemic.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Auburn:


1. The City authorizes the expenditure of **\$10,000** from the Opioid Settlement Fund to support the following approved use: **Serenity House Inc. program costs.**
2. Allocated funds are to be used for **participant drug screening and additional costs associated with the program.**
3. All expenditures shall comply with Indiana Code 4-6-15 and shall be tracked in a dedicated fund.
4. The Mayor and Clerk-Treasurer are authorized to take all necessary actions to carry out this resolution.
5. This Resolution shall be in full force and effect from and after its passage in accordance with the law.






