ORDINANCE NO. 2026-15

AN ORDINANCE ESTABLISHING A FUND FOR THE AUBURN FIRE DEPARTMENT CADET FIREFIGHTER PROGRAM

SECTION 1. That the Common Council of the City of Auburn, Indiana (“City”) desires to establish a fund for Auburn Fire Department Cadet Firefighter Program.

WHEREAS, The Common Council of the City has been made aware that the Auburn Fire Department Cadet Firefighter Program is an asset to the City in that it serves to provide training and experience to those individuals who have interest in being trained and educated on what it means to serve as a firefighter; and

WHEREAS, the Auburn Fire Department Cadet Firefighter Program has costs for administering the program along with equipment and event costs; and

WHEREAS, establishing this fund will allow for gifts and donations from the community at large and any other sources to support this valuable program; and

WHEREAS, a separate fund is necessary to properly account for the receipts and disbursements of monies received from any source.

NOW, THEREFORE, BE IT ORDAINED, by the Common Council of the City of Auburn, Indiana, as follows:

1. **CREATION OF FUND.** The City hereby creates and establishes a special fund known as the “Auburn Fire Department Cadet Firefighter Program Fund” to receive and disburse donations received.
2. **PURPOSE OF FUND.** The primary purpose of the fund is to accurately track the receipts and disbursements of donations made toward the Auburn Fire Department Cadet Firefighter Program.
3. **RESPONSIBILITY OF FUND.** The Clerk-Treasurer of the City shall be responsible for the deposits and disbursements of the fund and shall keep records as to the disbursements, receipts, and current balance in such fund at all times.

4. DEPOSIT OF FUNDS. Upon the receipt of donations directed to the Auburn Fire Department Cadet Firefighter Program Fund, the Clerk-Treasurer shall immediately deposit all receipts into the Auburn Fire Department Cadet Firefighter Program Fund.
5. APPROPRIATION AND NON-REVERTING. Auburn Fire Department Cadet Firefighter Program Fund shall be a non-appropriated and non-reverting fund.
6. DISSOLUTION OF FUND. The fund shall be perpetual unless or until terminated or amended by the Common Council of the City. Upon termination of the fund, the balance thereof shall revert to the General Fund.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.


