ORDINANCE 2026-22

AN ORDINANCE FOR THE ADDITIONAL APPROPRIATIONS OF FUNDS

WHEREAS, the Common Council of the City of Auburn, Indiana, has previously adopted an ordinance approving its budget for 2026; and

WHEREAS, the Common Council of the City of Auburn desires to appropriate \$23,877.09 from Fund 4445 – TIF (NW Allocation area) Fund; and

WHEREAS, adequate funds exist in the unappropriated and unobligated balance of the Fund;

WHEREAS, appropriations have been recommended by the Clerk-Treasurer of the City of Auburn.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA, that for the expenses previously described herein, the additional sums of money set forth below are hereby appropriated as follows:
