NOW, THEREFORE, BE IT RESOLVED, that the City of Auburn hereby adopts the DeKalb County Multi-Hazard Mitigation Plan as an official plan applicable to the Municipal City of Auburn;

IT IS HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA AS FOLLOWS: That the DeKalb County Department of Homeland Security will submit on behalf of the participating municipalities the adopted Multi-Hazard Mitigation Plan to the Indiana Department of Homeland Security and the Federal Emergency Management Agency for final review and approval.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE MUNICIPAL CITY OF AUBURN, DEKALB COUNTY, INDIANA, THAT:

This Resolution shall be in full force and effect from and after its passage by the Common Council and signing by the Mayor, and appropriate publication in accordance with Indiana law.
