Police Department

School Crossing Guard	\$110.00 bi-weekly
Drug Grant Case Manager	\$9.50 - \$12.50 per hour
ICJI Grants	Not to exceed grant limits
Other Grants	Not to exceed grant limits
Police Reserves [Avg. 16 hrs. /per month]	\$200.00 annually
	Paid to the Benevolent Fund
K-9 Officers	\$50.00 Bi-weekly or 1 day off per month
