At the Public Hearing, the Common Council will consider a request to vacate two undeveloped half-street rights-of-way extending north and south from Superior Drive east of Dewey Street and west of Tecumseh Court on the east edge of the Donald Shutt Amended Addition to the City of Auburn. The north half-street right-of-way to be vacated is 25-feet by 125-feet. The south half-street right-of-way to be vacated is 25-feet by 125-feet.


