### **ORDINANCE NO. 2017-09**

# AN ORDINANCE OF THE CITY OF AUBURN, INDIANA ADOPTING A NEW SCHEDULE OF RATES AND CHARGES FOR SERVICES RENDERED BY AUBURN MUNICIPAL WATER DEPARTMENT

#### **SUMMARY**

This Ordinance establishes that the City of Auburn, Indiana, owns and operates a municipal water utility known as the Auburn Municipal Water Department (the "Utility") for the purpose of providing water service to residential, commercial and industrial customers within the City of Auburn, Indiana and contiguous areas in DeKalb County. The Utility's existing rates and charges for services were placed into effect on January 1, 2000, following (i) the Indiana Utility Regulatory Commission's ("Commission") approval thereof in Cause No. 41414 on September 22, 1999, and (ii) adoption of an Ordinance by the Common Council of the City of Auburn. The Utility intends to file with the Commission a verified petition seeking approval of a new schedule of rates and charges that would reflect "reasonable and just rates and charges for services" within the meaning of Ind. Code § 8-1.5-3-8 and for the issuance of bonds to fund proposed projects and future capital improvements in accordance with Ind. Code § 8-1.5-2-19. #### **ORDINANCE NO. 2017-09**

## AN ORDINANCE OF THE CITY OF AUBURN, INDIANA ADOPTING A NEW SCHEDULE OF RATES AND CHARGES FOR SERVICES RENDERED BY AUBURN MUNICIPAL WATER DEPARTMENT

IT IS HEREBY ESTABLISHED AND ORDAINED by the Common Council of the City of Auburn, Indiana, that:

WHEREAS, the City of Auburn, Indiana, owns and operates a municipal water utility known as the Auburn Municipal Water Department (the "Utility") for the purpose of providing water service to residential, commercial and industrial customers within the City of Auburn, Indiana and contiguous areas in DeKalb County; and

WHEREAS, the Utility's existing rates and charges for services were placed into effect on January 1, 2000 following (i) the Indiana Utility Regulatory Commission's ("Commission") approval thereof in Cause No. 41414 on September 22, 1999, and (ii) adoption of an Ordinance by the Common Council of the City of Auburn; and

WHEREAS, the Utility intends to file with the Commission a verified petition seeking approval of a new schedule of rates and charges that would reflect "reasonable and just rates and charges for services" within the meaning of Ind. Code § 8-1.5-3-8 and for the issuance of bonds to fund proposed projects and future capital improvements in accordance with Ind. Code § 8-1.5-2-19; and

WHEREAS, the Board of Public Works of the City of Auburn, Indiana, adopted a Resolution on August 10, 2017, which: (i) approved a new schedule of rates and charges for water service provided by the Utility for customers located within and outside the City based upon a

study of the Utility's revenue requirements under Ind. Code § 8-1.5-3-8, and (ii) recommended said rates and charges to the Common Council for its review and approval; and

WHEREAS, the Common Council of the City of Auburn now finds: (i) the existing water rates and charges do not produce an income sufficient to maintain the utility property in a sound physical and financial condition to render adequate and efficient service; (ii) the Utility's existing rates and charges do not produce revenues sufficient to provide for all the legal and other necessary expenses incident to the operation of the Utility and, therefore, such current rates and charges are not "reasonable and just charges" within the meaning of Ind. Code § 8-1.5-3-8 and need to be increased; (iii) Financial Solutions Group, Inc., in consultation with the Utility's management has determined that the cost of providing service to customers located outside the City exceeds the cost to provide service to customers located inside the City and that a 15% surcharge should be added to the rates and charges applicable to customers located outside the City to recognize these cost differences and the fact that customers within the City are essentially owner customers who bear the risks and responsibilities of ownership in the Utility; and (iv) the proposed rates and charges attached hereto as Exhibit "A" for customers located within and outside the City are designed so that they are nondiscriminatory, "reasonable and just charges" for services within the meaning of Code § 8-1.5-3-8.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE

CITY OF AUBURN, INDIANA, THAT:

Section 1. The schedule of rates and charges attached hereto as Exhibit "A" is hereby

adopted as and for the rates and charges to be utilized by Auburn Municipal Water Department

when charging customers for water service, effective as set forth below.

Section 2. All Ordinances and parts of Ordinances in conflict herewith are hereby

repealed; provided, however, that the Utility's existing schedule of water rates and charges shall

remain in full force and effect until the schedule of rates and charges fixed by this Ordinance shall

be approved by the Indiana Utility Regulatory Commission, and until such time as the Order of

said Commission approving said new rates and charges shall direct.

Section 3. This Ordinance shall be in full force and effect from and after its passage;

provided, however, that the schedule of rates and charges herein adopted shall not become effective

unless and until approved by the Indiana Utility Regulatory Commission or until such time as said

Commission shall direct.

#### Water Service Attachments

All applications for service attachments to the water distribution for the purpose of introducing water into any premise, as well as applications for the use of water, must be made at the Department of Building, Planning and Development Office by the owner of the premise into which water is proposed to be introduced. The application shall be upon forms prescribed by the Department and signed by the applicant or his authorized agent.

The applicant shall pay in advance the following water tap charges, which shall include a corporation stop, curb stop, service box, copper tubing, backhoe, operator service and labor:

#### Non-Recurring Charges

The following non-recurring charges shall be made for the transaction and/or services as specifically set forth:

Remote Installation Charge \$27.80
Frozen Meter Installation Charge 100.00 \*

### **Temporary User**

Water furnished to temporary users, such as contractors, etc... shall be charged on the basis of the above gallonage rates as estimated by the Waterworks Superintendent. When a meter is installed for such purposes, the regular water rates and service charges shall apply and the temporary user shall pay for the installation and removal of the meter.

#### **Collection and Deferred Payment Charges**

All bills for water services not paid within seventeen (17) days from the due date thereof, as stated in such bills, shall be subject to a collection or deferred payments charge of 10% on the first \$3.00 and 3% on the excess over \$3.00.
