This Ordinance proposes to fix the salaries for the elected officers of the City of Auburn for the year 2019. The salaries for 2018 shall be: 1) \$2,575.00 biweekly for the Mayor; 2) \$2,523.50 biweekly for the Clerk-Treasurer; and 3) \$196.91 biweekly for the Members of Council.

**BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN,
INDIANA, THAT:**

Section 1.

Salaries for the elective officials of the City of Auburn for the year 2019 are hereby fixed
in the following amounts:

MAYOR:

TOTAL: \$2,575.00 Biweekly

CLERK-TREASURER:

TOTAL: \$2,523.50 Biweekly

COUNCIL MEMBERS:

TOTAL: \$196.91 Biweekly

Section 2.

BE IT FURTHER ORDAINED that Elective Officials shall be paid biweekly beginning
with the first pay period payable in January 2019.

Section 3.

BE IT FURTHER ORDAINED that salaries shall be paid with funds from Utilities, Fire Territory and, where applicable, Municipal funds.

Section 4.

BE IT FURTHER ORDAINED that the City of Auburn shall pay for each eligible Elective Official's contribution to Public Employees Retirement Fund that is required by Indiana State statute.

Section 5.

BE IT FURTHER ORDAINED that this Ordinance be in full force and effect from and after its passage by the Common Council and signing by the Mayor.
