Freshmen research native organisms

WATERLOO — DeKalb New Tech freshmen have been tackling the question of "What does an organism have to do in order to stand the test of time?" in their World Bio course for the past five weeks.

The course intertwines the subject content of world geography and biology as students engage in real-world and authentic learning experiences. Evolutionary theories, transformation of species populations, conservation of organisms, history and composition of Earth, as well as geography tools were among the lessons students explored in formulating an answer to the driving question.

The students researched native organisms of northeast Indiana such as the tiger salamander, Massasauga rattlesnake, great horned owl, Indiana bat and gray treefrog, encompassing 10 organisms altogether. Students learned

research processes, tips and techniques from viable online searches in reputable databases to navigating organism field guides used in environmental profes-

During the research phase, students came across many devastating impacts that the human population has on species, such as habitat destruction and lack of awareness. Students were asked by Lisa Conrad to participate in the second annual Kids Mini Monarch Fest Sept. 8 at DeKalb High School. Conrad shared with the students her passion for conserving monarch butterflies by teaching about the monarch's life cycle, migration, anatomy and conservation efforts. Students transformed their learning and created 10 child-friendly activities to enlighten community youth about the importance of monarch conservation. In class, Conrad also tagged a monarch butterfly, and the class will track its migration

in hopes that it safely arrives in Mexico.

In culmination, students traveled to Pokagon State Park and gave informative presentations, participated in a scavenger hunt as they explored the nature center and walked the trails on a guided hike lead by naturalist Nicole Ball.

Pokagon State Park plans to use the student presentations as training materials for interpretive program guides and seasonal naturalist workers.

As the class reflected on the experience of the project, freshman, Zach Squires, said, "I like how the project was relevant to our learning and the DeKalb community.

Season's final 'stroll' set for Chain O' Lakes

ALBION — Even though summer is winding down, taking a stroll in the woods still will provide fresh air and memories of green as the leaves start to turn for autumn.

In cooperation with Chain O' Lakes State Park, the Noble County Parks and Recreation Board's final 2018 Take A Stroll Saturday event explores one of the best natural assets in the

On Saturday, Chain O' Lakes State Park celebrates National Public Lands Day by waiving all entry fees into the park. In addition to a hike leaving from the beach at 9 a.m., the staff at the park wil hold several other events throughout the day. Participants can remove invasive species in the afternoon, meet an 18th century fur trader at 2 p.m., or join in activities at the historic Stanley Schoolhouse all day.

Chain O' Lakes State Park is a 2,700-acre park with 10 miles of forested trails, nine connected lakes with fishing, boat rentals, camping facilities, a beach and a nature center. The park is south of Albion on S.R. 9.

On a Saturday each month from May through September, the Noble County Parks and Recreation Board has worked with other local organizations to host

Tale A Stroll Saturday, a trail hike featuring an area trail. The hikes highlight the variety of facilities that Noble County has to offer. They also gave local organizations the opportunity to interact with the public and promote their missions.

The Noble County Parks and Recreation Board is in the midst of updating its master plan for 2019 by gathering public input through an on-line survey at bit.ly/NobleParksPlan, or it can be accessed through the Board's website at noblecoparks.wixsite.com /website.

The Noble County Parks and Recreation Board was created in 2010 by the Noble County Council in response to a recommendation in the 2007 Noble County Comprehensive Plan. After assessing the recreational assets throughout the county, the board's mission is to promote the recreational opportunities that exist. In public input sessions in 2013 and 2014, citizens cited trails as the most desired recreational facility.
