BE IT FURTHER RESOLVED, that the Clerk-Treasurer of the City of Auburn is hereby directed to submit a copy of the Resolution to the Auditor / Assessor of DeKalb County, Indiana as appropriate with a request that the waiver be implemented pursuant to this Resolution.
