Summary

This Resolution calls for the City of Auburn, Indiana, to create a position by funding a Community Coordinator should the City become a HOOSIER ENDURING LEGACY PROGRAM (HELP) recipient. Further, the City of Auburn, Indiana commits \$20,000.00 for said position for 2022 and \$40,000.00 for 2023. Further, the City establishes a Core Committee appointed by the Mayor to act as a liaison. Further, the Help Community Coordinator position shall be an employee of Auburn Main Street and the salary, withholdings and supervision of said position shall be the responsibility of Auburn Main Street.

WHEREAS, the City of Auburn, Indiana, recognizes the effect of the Coronavirus public health crisis on the citizens of Auburn, the local capacity of Auburn, and the workforce of Auburn; and

WHEREAS, the City of Auburn, Indiana, receives funds from the Coronavirus Local Fiscal Recovery Fund, created under the American Rescue Plan Act, passed by the current administration; and

WHEREAS, the City of Auburn, Indiana, will apply to the Indiana Office of Community and Rural Affairs for the Hoosier Enduring Legacy Program;

NOW, THEREFORE, BE IT RESOLVED by the Common Council of Auburn, Indiana, that:

- Auburn Main Street and the Committee are authorized to conduct interviews to fill a
 Community Coordinator position as outlined in the job description provided by the
 Indiana Office of Community and Rural Affairs.
- 2. The Mayor of the City of Auburn shall appoint a Core Committee to act as advisor and liaison to the City of Auburn with regard to HELP.

3. Auburn Main Street shall be responsible for the supervision, payment of salary and withholdings of said new Coordinator position.

4. Auburn Main Street shall employ an individual to act as Coordinator for a minimum 30 hours per week on the Hoosier Enduring Legacy Program Grant.

 Said Coordinator shall comply with the job description provided by the Indiana Office of Community and Rural Affairs.

6. The City of Auburn, Indiana, hereby commits local funds to be used in 2022 in the amount of Twenty Thousand Dollars (\$20,000), from Coronavirus Local Fiscal Recovery Fund, for the starting salary of the Community Coordinator Position, to be matched with Twenty Thousand Dollars (\$20,000) by the Indiana Office of Community and Rural Affairs. Such commitment is to be contingent upon recognition as a HELP-designated community provided by the Indiana Office of Community and Rural Affairs. The City of Auburn shall commit funds in the amount of Forty Thousand Dollars (\$40,000), to be used in 2023.
