THAT, the Zoning Map of the City of Auburn shall be amended in the following manner: The 1.6-acre parcel located at 259 Center Street, Auburn and owned by Larry K. Steffen and Shannon E. Steffen shall officially be changed to the R2 (Medium Density Single-Family Residential). The tract of land is illustrated in Exhibit B, attached hereto. The zoning change shall also apply to associated rights-of-way, to the centerline of the street.

BE IT FURTHER ORDAINED that this Ordinance be in full force and effect after its passage by the Common Council and after the occurrence of all other actions required by law.
