# ORDINANCE NO. 2022-10 AN ORDINANCE TO AMEND THE ZONING MAP OF THE CITY OF AUBURN, INDIANA

WHEREAS, Ordinance No. 2018-24, as amended, adopted an Official Zoning Map for the City of Auburn, Indiana; and

WHEREAS, Indiana Code section §36-7-4-600 et. seq provides for amendments to the zoning map of a municipality by ordinance of the municipality; and

WHEREAS, this amendment to the Zoning Map assigns a zoning district that will accommodate single-family residential dwellings units with reduced building setbacks on the identified lots within the Bridgewater North Section II subdivision phase; and

**WHEREAS**, the City of Auburn Plan Commission at its July 12, 2022 meeting held a legally advertised Public Hearing; and

**WHEREAS**, the City of Auburn Plan Commission, on July 12, 2022, heard input from the public and ultimately forwarded a *favorable recommendation* to the Auburn Common Council with ten votes in favor of the favorable recommendation and no votes against the favorable recommendation concerning the rezoning of said real estate.

## NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA:

**THAT,** the Zoning Map of the City of Auburn shall be amended in the following manner: That lots 92-117, 119-125, and 127-145 of the Bridgewater North Section II subdivision plat be rezoned to R2 (Medium Density Single-Family Residential) District. The tract of land is illustrated in Exhibit A, also attached hereto.

**BE IT FURTHER ORDAINED** that this Ordinance be in full force and effect after its passage by the Common Council and after the occurrence of all other actions required by law.


