**AN ORDINANCE AMENDING SECTION 31.15 STANDING COMMITTEES OF
THE AUBURN COMMON COUNCIL**

WHEREAS, the Common Council desires to have the President of the Common Council appoint the Standing Committees of the Common Council; and

**NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF AUBURN, INDIANA**, as follows:

Section 1.

In Chapter 31 of the Auburn City Code of Ordinances, Section 31.15 shall be amended to authorize the President of the Common Council to appoint the Common Council Standing Committees. Section 31.15 shall read and be codified in the Auburn City Code as follows:

31.15 STANDING COMMITTEES

- A. The following standing committees shall be annually appointed by the President of the Common Council at the first regular meeting in January of the Common Council, of which the first named shall be the Chair: Finance, Tax Phase-In, and Ordinances and Resolutions, and shall each be composed of three members from the Common Council.
- B. These committees shall perform the duties required by the Council and report their actions at any meeting of the Common Council whenever called upon to do so.

Section 2.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after its passage and publication in a paper of general circulation within the County of DeKalb, State of Indiana. This Ordinance shall be retained by the Office of the Clerk-Treasurer and further placed in a booklet form for availability to the public upon request.

BE IT FURTHER ORDAINED that the codified version of Section 31.15 shall be placed on the City of Auburn website at www.ci.auburn.in.us as further set forth herein.
