#### **ORDINANCE 2024-23**

#### AN ORDINANCE FOR THE ADDITIONAL APPROPRIATIONS OF FUNDS

WHEREAS, it has been determined that it is now necessary to increase the funding originally appropriated in the annual budget;

WHEREAS, the Auburn Common Council ("Council") is the fiscal body of the City of Auburn, Indiana (the "City");

WHEREAS, the U.S. Department of the Treasury Final Rule to implement the Coronavirus Local Fiscal Recovery Fund ("Final Rule") allows the use of ARPA Coronavirus Local Fiscal Recovery Fund ("Fund") money to be used to provide government services to the extent of reduction in revenue, which reduction is presumed to have been due to the COVID-19 public health emergency;

WHEREAS, adequate funds exist in the unappropriated and unobligated balance of the Fund;

WHEREAS, appropriations have been recommended by the Clerk-Treasurer of the City of Auburn.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA:
