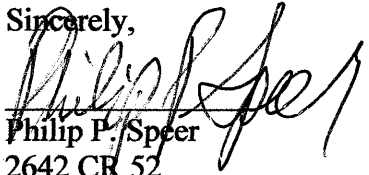

We are quite concerned with the recent City & County activities taking place with zoning map proposals in the area of our homes and properties. There seems to be some conflicts between what was in "The Star" on April 15th, 2009 debating this zoning (in a meeting the day before), with the Auburn Plan Commission. The article states that properties, immediately south of the city, were to **remain as residential**. Some of us have attended meetings with both Zoning Administrators of the City and County to be shown maps of something different than that decision. I, this letter's author, also attended the County Council meeting held May 4, 2009 and was given the opportunity to state our sincere concerns.

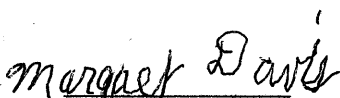
