The salaries for 2014 shall be: 1) \$2,019.92 Biweekly for the Mayor; 2) \$1,951.64 Biweekly for the Clerk-Treasurer; 3) \$171.50 Biweekly for the Members of the Council; 4) \$50.00 per meeting per diem for the Member of the Council who serves on the Plan Commission and \$20.00 per meeting per diem for the Member of the Council who serves on the Plan Commission Sub-Committee.

**BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN,
INDIANA, THAT:**

Section 1.

Salaries for the elective officials of the City of Auburn, Indiana, for the year 2014 are hereby fixed in the following amounts:

Section 2.

BE IT FURTHER ORDAINED that Elective Officials shall be paid biweekly beginning with the pay period payable January 1, 2014.

Section 3.

BE IT FURTHER ORDAINED that the City of Auburn shall pay for each eligible Elective Official that contribution to Public Employees Retirement Fund that which is required by Indiana State statute.

Section 4.


BE IT FURTHER ORDAINED that this Ordinance be in full force and effect from and after its passage by the Common Council and signing by the Mayor.


