ORDINANCE NO. 2015-05

AN ORDINANCE TO TRANSFER FROM THE FIRE OPERATING FUND TO THE CUMULATIVE FIRE EQUIPMENT FUND IN ACCORDANCE WITH I.C. 36-8-19-8

WHEREAS, Indiana Code 36-8-19-8 establishes a Fire Protection Territory Fund; and

WHEREAS, the Common Council of the City of Auburn and Union Township have previously established the Auburn/Union Township Fire Territory; and

WHEREAS, the Municipal unit of Government when necessary may pass ordinances and/or resolutions to authorize the transfer of funds from the operating fund to the cumulative fire equipment fund to pay for costs associated with the of equipment to serve the Fire Protection Territory; and

WHEREAS, the Municipality shall pass an ordinance and the Township shall pass a Resolution authorizing said transfer(s); and

WHEREAS, in the case of the Auburn/Union Township Fire Territory it is necessary to make said transfer; and

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA, THAT:

Section I.

The Clerk-Treasurer of the Municipal City of Auburn shall be authorized to transfer \$100,000.00 from the Fire Operating Fund to the Cumulative Fire Equipment Fund and further that Union Township shall pass a similar Resolution authorizing the same.

Section II.

BE IT FURTHER ORDAINED that this Ordinance be in full force and effect from and after its passage by the Common Council and signing by the Mayor.


