## AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF AUBURN

**WHEREAS,** Ordinance No. 89-01, as amended, adopted a Zoning Map for the City of Auburn, Indiana; and

**WHEREAS,** the City of Auburn Plan Commission has conducted a Public Hearing on June 14, 2016 as required by law in regard to a request to amend the Zoning Map of the City of Auburn; and

**WHEREAS,** the City of Auburn Plan Commission at its June 14, 2016 meeting made the required findings of fact and forwarded a favorable recommendation to the Auburn Common Council by a vote of seven in favor and zero opposed concerning the rezoning of certain real estate located within the City of Auburn, Indiana; and

**WHEREAS,** Indiana Code section 36-7-4-600 et. Seq provides for amendments to the zoning map of a municipality by ordinance of the municipality, and

# NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUBURN, INDIANA:

**THAT**, the Zoning Map of the City of Auburn shall be amended in the following manner:

The zoning of the parcel at 424 West Ninth Street, Auburn Indiana and the adjacent parcel to the west shall be changed from the R-3 District (Multi-Family Residential) to the C-2 (General Commercial) District. More specifically, these parcels are legally described as Lot numbered thirty-nine (39) in Fluke's Third Addition to the town, now City of Auburn, DeKalb County, Indiana; and Lot numbered thirty-eight (38) in Fluke's Third Addition to the town, now City of Auburn, DeKalb County, Indiana with an aerial photo of the lots attached as Exhibit A.

**BE IT FURTHER ORDAINED** that this Ordinance be in full force and effect after its passage by the Common Council and after the occurrence of all other actions required by law.
